Terms of Reference

The Sub-Committee shall:

- Examine the existing legal and administrative framework governing pre-trial scrutiny of challans in criminal cases;
- Devise and recommend a uniform policy for effective and efficient prosecution in the Province of Sindh with particular reference to pre-trial scrutiny of challans;
- Propose Standard Operating Procedures (SOPs) and implementation mechanisms for enforcement of the proposed policy;
- Identify procedural and legal bottlenecks, if any, and recommend appropriate measures for their removal; and
- Submit its report and recommendations to the aforesaid Committee at the earliest for consideration and onward submission to the Hon'ble Minister for Home, Law, Parliamentary Affairs and Criminal Prosecution, Sindh.


